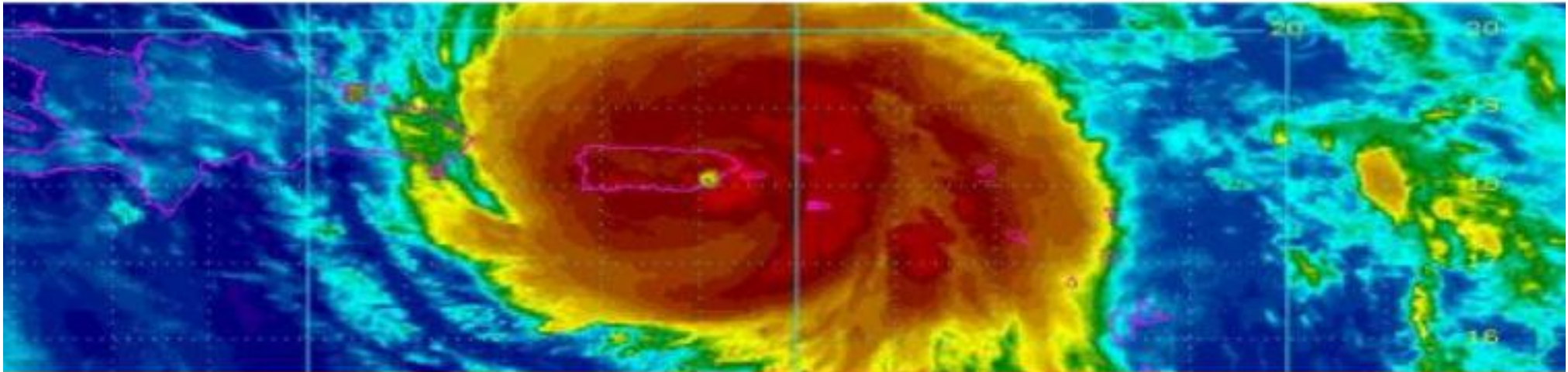
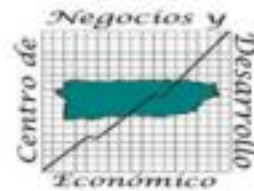

What is the DUNS Number

- DUNS = Data Universal Numbering System
- A DUNS number is a unique nine-character number used to identify your organization issued by Dun & Bradstreet on a location-specific basis. The federal government uses the DUNS number to track how federal money is allocated.
- is not just a number—it is a system for maintaining accurate, comprehensive and timely information – and it is issued rapidly and free of charge for all entities wanting to do business with the U.S. Federal Government.
- **It is free!** If you encounter any organizations or websites soliciting a fee or charge to acquire a DUNS number it is likely a scam or companies offering their services.

What do you need for the DUNS

- Name of organization
- Organization address
- Name of the chief executive officer (CEO) or organization owner
- Legal structure of the organization (e.g., corporation, partnership, proprietorship)
- Year the organization started
- Primary type of business
- Total number of employees (full and part-time)
- Email
- Square Footage of primary place

DUNS

- Must allow up to two business days to obtain a DUNS number, but it can occur in one business day.

Ways of Obtaining a DUNS Number

- By Toll-Free Telephone
 - 1-(866) 705-5711. Tell the operator that you are applying to a Federal financial assistance program and need to register for a DUNS number.
